The Scientific Committee of the Conference reserves the right to review the abstracts and assign them as spoken papers or poster presentations. The basic criteria of qualifying the abstracts will be their academic value and relevance to the conference topics. Abstracts should not exceed a half A4 page.

The papers accepted for presentation during the conference (max 10 pp) after positive review will be published in the monograph, which publishes the papers of Professor AleksanderZelias International Conference on Modelling and Forecasting of Socio-Economic Phenomena. Monograph will be sent to the **Conference Proceedings Citation Index - Social Science & Humanities (CPCI-SSH)** which is integrated index within **Web of Science™ Core Collection database**. If they are accepted, they will be available in the **Web of Science™ Core Collection database**. Furthermore, the papers from Conference Proceedings are indexed in the Google Scholar.

The conference proceedings of The 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup> and 11<sup>th</sup> *Professor AleksanderZelias International Conference on Modelling and Forecasting of Socio-Economic Phenomena* have already been included to the *Web of Science™ Core Collection Database* and are indexed in the Google Scholar.

It is also possible to publish the paper in English (original research article which has not been previously published; up to 40 000 characters i.e. including tables, figures, references, author's box at the end of the article, etc.) after positive review in *Entrepreneurial Business and Economics Review (EBER)* or *Central European Journal of Economic Modelling and Econometrics (CEJEME)*, which are indexed in **Emerging Sources Citation Index (ESCI) - Web of Science Database** and **Scopus**.
