The Scientific Committee of the Conference will review the abstracts and assign them as spoken papers or poster presentations. The main criteria for qualifying the abstracts will be the scientific value and relevance to the conference topics. Abstracts should not exceed **half of the A4 page**.

**Until May 23, 2022**, the organizers will inform Authors about the publication proposal by e-mail, and the authors should submit a text to the editorial office of the journal indicated by the organizers **until June 30, 2022**. It is required to prepare the manuscript following the editorial requirements of the journal. The final decision depends on the receiving of positive reviews. If an article is accepted for publication in *Argumenta Oeconomica* an additional fee will be required.
